Minutes :

Motion to approve minutes from December 3rd made by Commissioner Spivey, Seconded by Commissioner Goodrich. Unanimous Decision, motion carried. 5-0..

Motion to approve minutes from December 17th made by Commissioner Stewart, Seconded by Commissioner Spivey. Unanimous Decision, motion carried. 5-0.

Old Business:

Cemetery surveying is necessary in the coming future. Suggested to hold special call meeting/workshop for this issue to discuss further.

The remainder of the Covid Relief Funds in the approximate amount of \$700.00 that the Town of Hamilton received in 2020 was discussed briefly. Where it was noted further information was said to be needed to look into a sanitation machine to disinfect areas around town or other possibilities for the funds. Requested to look into what other municipalities are using the remainder of their funds for.

New Business:

Proposal for the utilities and procedures ordinance was presented to the board. A workshop was scheduled for January 21st at 7:00pm to go over the procedure's ordinance and revise items that needed attention, as well as to further discuss the cemetery.

Town Comment:

Town Residents Mr. and Mrs. Sullivan inquired about information shared about the cemetery. Inquiring about the reasoning for the price of the cemetery surveying and why it was so much. Suggested we get more quotes from different places including in Washington, NC. Mr. and Mrs. Sullivan also inquired about zoning ordinances and the permitting of different visible structures or items on Front Street in Hamilton.

Commissioner Spivey- Rainfall has been a challenge to the Town of Hamilton, and we need to make moved towards fixing these issues. It causes a lot of issues with the possibility of washing out the waste water plant.
